### User guide

#### DESCRIPTION:

Solution of non-ionic surfactants and glycol-ethers with degreasing action. Does not leave opaque halos.

#### FIELDS OF APPLICATION:

For the ordinary cleaning of treated and non-treated stone materials, such as cotto, natural stone and terrazzo.

#### CHARACTERISTICS:

**FLORA** is a concentrated detergent for the ordinary cleaning of cotto floors and stone materials treated with wax and not.

#### **FLORA:**

- is a neutral detergent that cleans and does not spoil stone materials and wax treatments;
- is ideal for the ordinary cleaning of floors and surfaces in cotto, stone and terrazzo;
- leaves no halos and releases a pleasant scent of lavender in the rooms;
- is a low foaming detergent and can be used with scrubber-dryers.

#### INSTRUCTIONS FOR USE:

• Dilute 250-500cc of FLORA in 1 liter of water: for an extraordinary degreasing cleaning of untreated floors depth or to eliminate accumulation of dirty and deteriorated maintenance waxes on treated floors.

- Spread FLORA on the floor with a microfiber cloth and leave for a few minutes;
- Rub the surface with red pad or disc;
- Finally rinse with a microfiber cloth and clean water.

• Dilute 30-50cc in FLORA in 5 liters of water: for periodic cleaning.

- It is applied as a normal detergent with a microfiber cloth.

• Dilute 10-20cc of FLORA in 5 liters of water: for daily cleaning.

- It is applied as a normal detergent with a microfiber cloth. In this dilution you can also use scrubber-dryers.
