DESCRIPTION:

Concentrated detergent solution based on water, glycols, dispersants, sequestrants, anionic and non-ionic surfactants. Contains no caustic soda, potash or ammonia.

FIELDS OF APPLICATION:

Gelcoat, inflatables, plastics, skay, fenders, PVC, aluminum and other metals.

CHARACTERISTICS:

DIAMOND BOAT is a concentrated cleaning solution for the removal of the most stubborn dirt accumulated on the surfaces of boats such as: gelcoat, rafts, plastics, skay, fenders, PVC, aluminum and other metals.

DIAMOND BOAT:

- is a professional degreasing cleaner concentrated for the removal of dirt even the most stubborn accumulated on the surfaces of boats and rafts;
- removes dust, oily films, grease and organic residues from external surfaces renewing the color and leaving them clean and without greasy residues;
- is easy to rinse and leaves no stripes or streaks.

INSTRUCTIONS FOR USE:

- Apply the product and let it act for a few seconds (light dirt) or for a few minutes (heavy dirt);
- Rub the surface with red buffer until all the greasy dirt melts;
- Remove loose dirt with soft cloth or sponge;
- Rinse with clean water.

Dosages:

- Pure: to remove extreme dirt;
- Diluted 1 part of DIAMOND BOAT in 1 part of water: to remove heavy dirt;
- Diluted 1 part of DIAMOND BOAT in 5 parts water: to remove the normal dirt deposit.

Avoid contact with real leather and hide.

PRECAUTIONS:

- do not use on fabrics, real leather and hide.

PACKAGING:

- 1 lt Pe bottle – box 6 pieces;
- 5 lt Pe tank – box 4 pieces.

YIELD:

- Depending on the dirt to be removed.

TECHNICAL DATA:

- Physical state: pink liquid
- Specific gravity (g/cm³): 1,004
- pH (20 ?? C) of the pure product: 11
- Flame point (ASTM): non-flammable
- Solubility in water: soluble in water.

STORAGE:

Keep the product tightly closed and at a temperature between 5 and 30 °C in an aerated environment, away from heat sources and not exposed to sunlight for a long time. When stored at low temperatures (<10 °F) the product can become dense, but without affecting its use or performance. The stored product has a useful life of 5 years.
