User guide

DESCRIPTION:

Alkaline-solvent solution made of water, solvents, amines, low foaming surfactants, sequestrants. It does not contain caustic soda.

FIELDS OF APPLICATION:

For normal or strong wax-stripping washing on all stone materials (cotto, stone, glazed ceramics, klinker, porcelain tiles, cement, grit, etc.).

CHARACTERISTICS:

METAL-STRIP is a detergent for the cleaning of all stone materials (terracotta, stone, glazed ceramics, klinker, porcelain tiles, cement, grit, etc.).

METAL-STRIP:

- is a strong detergent to quickly remove old layers of metallic wax and various polymers;
- has an effective exhausting action even at low concentrations;
- · no acid neutralisation required;
- has low foaming properties;
- does not release unpleasant odors during use and in environments.

Do not use on wood, linoleum, rubber, painted surfaces, aluminum.

INSTRUCTIONS FOR USE:

INSTRUCTIONS FOR USE:

It can be used pure or diluted in water depending on the type of dirt, the amount of residues to be removed and the cleaning technique adopted.

Dosages:

- Pure: on substantial accumulations of waxes and polymers;
- Diluted a part of METAL-STRIP in 4-8 equal parts of water: for washes where a normal degreasing action is necessary:
- Diluted a part of METAL-STRIP in 10-15 equal parts of water: for periodic washing with scrubbing machines.

How to use the product:

- Spread the product wetting the surface and let it act 5/10 minutes;
- Proceed to small areas (10-15 m²). Rub the surface with pads or discs made of plastic fibers;
- Remove the residues of the deceramento;
- Finally rinse with clean water;
- Repeat the application if necessary.

PRECAUTIONS:

- do not use on wood, linoleum, rubber and PVC;
- protect painted and anodized aluminium surfaces from contact with METAL-STRIP.

YIELD:

- for energetic washings 1 lt / 4-8 m²;
- for normal washings 1 lt / 10-15 m2.

TECHNICAL DATA:

- Physical state: clear colourless liquid
- Specific gravity (g/cm3): 1,062

STORAGE:

Keep the product tightly closed and at a temperature between 5 and 30 °C in an aerated environment, away from heat sources and not exposed to sunlight for a long time. The stored product has a useful life of 5 years.
