## User guide

### DESCRIPTION:

Strong alkaline solution in gel form.

### FIELDS OF APPLICATION:

Specific cleaner for the cleaning of the facades in stone materials such as: cotto, stone, glazed and unglazed ceramic, klinker, porcelain tiles, cement, grit, etc.

### CHARACTERISTICS:

**PULITORE FC** is a strong alkaline solution specific for the cleaning of walls made of stone materials.

#### **PULITORE FC:**

- is a gel product easy to apply, especially in vertical;
- degreases the surfaces by removing in depth crusts of smog, air pollution, fatty substances and organic encrustations;
- can also be used for cleaning vertical surfaces blackened by fire smoke;
- is odorless, does not contain solvents and is biodegradable.

### INSTRUCTIONS FOR USE:

It is used pure.

- Apply PULITORE FC with synthetic fiber brush on the surface and let it act at least 20-40 minutes;
- Rub the surface with plastic fiber buffers or with nylon brushes;
- On very porous materials it is recommended to neutralize PULITORE FC with diluted acid solution (e.g. 1:10 solution of DELICACID);
- Finally, rinse with pressure washer or with plenty of water until the product is completely removed.

### PRECAUTIONS:

- Do not use on painted surfaces, anodized aluminum and wood.

#### **WARNINGS: DANGER**

**Hazard statements:** Causes severe skin burns and eye damage.

**Precautionary statements:** Wear protective gloves / clothing and eye / face protection. – IF SWALLOWED: Immediately call a POISON CENTER or doctor / physician. – IF ON SKIN (or hair): Take off immediately all contaminated clothing. #### PACKAGING:

- 5 kg conf. Bucket – box 4 pieces.

#### YIELD:

Depending on the dirt to be removed and the absorption of the material.

- Average 1lt/ 4 – 8 m2 each coat.

#### TECHNICAL DATA:

- Physical state: yellowish gelatinous liquid
- Specific gravity (g/cm3): 1,09
- pH (20°C) of the pure product: 14
- Flame point (ASTM): non-flammable
- Solubility in water: partially soluble in water.

#### STORAGE:

Keep the product tightly closed and at a temperature between 5 and 30 °C in an aerated environment, away from heat sources and not exposed to sunlight for a long time. When stored at low temperatures (<10 °F) the product can become dense, but without affecting its use or performance. The stored product has a useful life of 5 years.
