User guide

DESCRIPTION:

Solution of fast biodegradable non-ionic surfactants and dirt breakers. It contains no caustic soda, ammonia, perfumes, dyes and solvents.

FIELDS OF APPLICATION:

For the ordinary cleaning of all stone surfaces such as porcelain tiles, ceramics, klinker, stone, cotto, terrazo.

CHARACTERISTICS:

ECOMARBEC is an ecological concentrated detergent for the cleaning of stone materials.

ECOMARBEC:

- is a hypoallergenic product that does not contain caustic soda, ammonia, perfumes, dyes and solvents;
- cleans, degreases, sanitizes the surfaces in cotto, stone, marbles, cement and synthetic terrazo,
- acts by dissolving the fatty substances, making them easily removable;
- can be used for manual and mechanical washing (eg washer dryer, pressure washer).

INSTRUCTIONS FOR USE:

It can be used pure or diluted in water.

Dosages:

- Dilute 1 part of ECOMARBEC in 2 equal parts of water: for heavily degreasing washes, to remove large amounts of greasy dirt (food / mineral oils, greases and stubborn dirt residues);
 - Spread ECOMARBEC on the floor with a rag, and let it act for a few minutes;
 - Rub the surface with sponges or medium-hard buffers;
 - Then rinse everything with clean water;
- Dilute 180-250cc of ECOMARBEC in 5 liters of water: for a periodic degreasing cleaning;
 - It is applied like a normal detergent with a microfibre cloth. In this dilution it is also possible to use scrubbing machines.
- Dilute 50-100cc of ECOMARBEC in 5 liters of water: for daily cleaning of all surfaces.
 - It is applied like a normal detergent with a microfibre cloth. In this dilution it is also possible to use scrubbing machines.

PRECAUTIONS:

- protect all wood surfaces from contact with pure ECOMARBEC.
