## **DESCRIPTION:**

Concentrated detergent solution based on non-ionic and cationic surfactants, coconut soap, and vegetable aromas.

## FIELDS OF APPLICATION:

For ordinary and extraordinary non-aggressive cleaning of all wooden surfaces, painted or treated with oil and/or wax.

## **CHARACTERISTICS:**

PULIBRILL is a concentrated neutral ph brightener detergent specific for cleaning wooden and parquet surfaces.

#### **PULIBRILL**:

- can be used for ordinary and extraordinary non-aggressive cleaning of all wooden surfaces, painted or treated with oil and/or wax;
- · cleans the wooden surface;
- does not attack the wood essence and the finish of the material;
- maintains the brilliance of the initial treatment over time.

## **INSTRUCTIONS FOR USE:**

The concentration of use depends on the type of dirt to be removed.

#### Dosages:

- Dilute 100-200 cc of PULIBRILL in 1lt of water: to perform an extraordinary cleaning to remove consistent dirt.
  - Spread the product on the surface with a rag and leave to act for a few minutes;
  - o Rub the surface with white buffer;
  - Finally, rinse everything with clean water.
- Dilute 10-15 cc of PULIBRILL in 1lt of water: for ordinary surface cleaning.
  - It is applied like a normal detergent with a microfibre cloth. In this dilution, it is also possible to use scrubbing machines.
